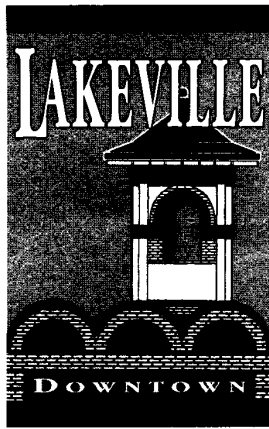

Also – have the meeting schedule put on the main page of the website.

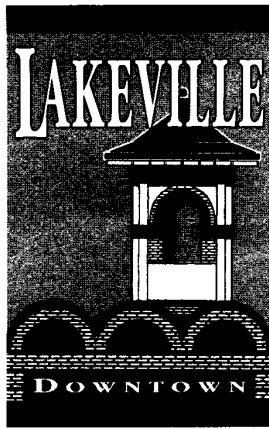
